Considering : a. that according to the provisions of Article 33
paragraph (6) of the Law of the Republic of
Indonesia Number 12 of 2012 concerning Higher



Education, study programs shall be re-accredited when the accreditation period ends;

- b. that according to the provisions of Article 4 paragraph (3) of the Regulation of the Minister of Education and Culture of the Republic of Indonesia Number 5 of 2020 concerning Accreditation of Study Programs and Higher Education, prior to the establishment of by an independent accrediting agency, study program accreditation was carried out by the National Accreditation Agency for Higher Education;
- c. that according to the provisions of Article 18 letter d. Regulation of the Minister of Education and Culture of the Republic of Indonesia Number 5 of 2020 concerning Accreditation of Study Programs and Higher Education, the National Accreditation Agency for Higher Education (BAN-PT) issues, amends, or revokes accreditation rating decisions and submits them to related parties;
