Considering: a. that in accordance with the provisions of
Article 33 paragraph (6) of Law of the Republic of
Indonesia Number 12 of 2012 concerning Higher
Education, study programs must be re-accredited
when their accreditation period ends;
b. that in accordance with the provisions of
Article 4 paragraph (3) of the Regulation of the
Minister of Education and Culture of the Republic
of Indonesia Number 5 of 2020 concerning
Accreditation of Study Programs and Higher
Education, before the formation of an independent
accreditation institution, accreditation of study



programs was carried out by the National Accreditation Agency for Higher Education;

- c. that in accordance with the provisions of Article 18 letter d. Minister of Education and Culture Regulation of the Republic of Indonesia Number 5 of 2020 concerning Accreditation of Study Programs and Higher Education, the National Accreditation Agency for Higher Education (BAN-PT) issues, amendments or revokes the accreditation rating decision and conveys it to the relevant parties;
- d. that based on the considerations as referred to in letters a, b, and c, it is necessary to determine the Decree of the National Accreditation Agency for Higher Education regarding the Accreditation Rating of the Informatics Study Program in the Bachelor's Program of Universitas Ciputra, Surabaya City.
