ACCREDITATION RATING CONVERSION OF INFORMATION SYSTEMS STUDY

Considering: that to implement the provisions of Article 9 of the National Accreditation Agency for Higher Education Regulation Number 1 of 2020 concerning Accreditation Mechanisms and based on the results of the assessment of the proposed conversion in accordance with the National Accreditation Agency for higher Education Regulation Number 2 of 2020 concerning the Conversion Supplement Instrument, it is necessary to stipulate a Decree from the National Accreditation Agency for Higher Education regarding the Conversion of Accreditation Ratings for Information Systems Study Programs in Bachelor's Programs of Universitas Ciputra, Surabaya City;

Observing:

1. Law Number 12 of 2012 concerning Higher Education (State Gazette of the Republic of Indonesia of 2012 Number 158, Supplement to State Gazette of the Republic of Indonesia Number 5336);
2. Minister of Education and Culture Regulation Number 3 of 2020 concerning National Higher Education Standards (State Gazette of the Republic of Indonesia of 2020 Number 47);
3. Minister of Education and Culture Regulation Number 5 of 2020 concerning Accreditation of Study



Programs and Higher Education (State Gazette of the Republic of Indonesia of 2020 Number 49);

4. Minister of Education and Culture Regulation Number 7 of 2020 concerning the Establishment, Amendment, and Dissolution of State Universities, and the Establishment, Amendment, and Revocation of Licenses for Private Universities (State Gazette of the Republic of Indonesia of 2020 Number 52);
5. Decree of the Minister of Education, Culture, Research and Technology of the Republic of Indonesia Number 380/P/2021 concerning Members of the Executive Agency of the National Accreditation Agency for Higher Education for the 2021-2026 period;

HAS DECIDED

To enact: DECREE OF THE NATIONAL ACCREDITATION AGENCY FOR HIGHER EDUCATION CONCERNING THE ACCREDITATION RATING CONVERSION OF THE INFORMATION SYSTEMS STUDY PROGRAM IN THE BACHELOR'S PROGRAM OF UNIVERSITAS CIPUTRA, SURABAYA CITY.

FIRST: Converting the accreditation rating for the Information Systems Study Program in the Bachelor's Program of Universitas Ciputra, Surabaya City as stated in the Decree of the National Accreditation Agency for Higher Education Number 3945/SK/BAN-PT/Akred/S/X/2019 concerning the Accreditation Rating of the Information Systems Study Program in the Bachelor's Program of Universitas Ciputra, Surabaya City, rated Good with a score of 291.

SECOND: The Study Program accreditation rating as referred to in the FIRST Dictum comes into force until October 16 2024.

THIRD: The Study Program accreditation rating as referred to in the FIRST Dictum can be revoked before the validity period ends, if the Information Systems Study Program in the Bachelor's Program of Universitas Ciputra, Surabaya City is proven not to fulfil the accreditation rating requirements.
