Considering : that in order to implement the provisions of

the results of the proposed conversion assessment
in accordance with the National Accreditation



Agency for Higher Education Number 2 of 2020 regarding Conversion Supplement Instruments, it is necessary to stipulate a Decree of the National Accreditation Agency for Higher Education regarding the Conversion of Tourism Study Program Accreditation Rating in the Undergraduate Program of Universitas Ciputra Surabaya, Surabaya City;

 3. Regulation of the Minister of Education and Culture Number 5 of 2020 concerning Accreditation of Study Programs and Higher Education (State Gazette of the Republic of Indonesia of 2020 Number 49);
 4. Regulation of the Minister of Education and Culture of the Republic of Indonesia Number 7 of 2020 concerning Establishment, Amendment, Dissolution of State Higher Education, and Establishment, Amendment, Revocation of Private Higher Education Permits (State Gazette of the Republic of Indonesia of 2020 Number 52);
 5. Decree of the Ministry of Research, Technology and Higher Education Number 328/M/KPT/2016 concerning Members of the Executive Board of the National



Accreditation Agency for Higher Education for the Period of 2016-2021 as amended by Decree of the Minister of Research, Technology and Higher Education Number 284/M/KPT /2017 concerning Amendments to the Decree of the Minister of Research, Technology and Higher Education Number 328/M/KPT/2016 concerning Members of the Executive Board of the National Accreditation Agency for Higher Education for the Period 2016-2021;

DECIDE:

- Stipulate : DECREE OF THE NATIONAL ACCREDITATION AGENCY FOR HIGHER EDUCATION REGARDING THE CONVERSION OF TOURISM STUDY PROGRAM IN UNDERGRADUATE PROGRAM OF UNIVERSITAS CIPUTRA SURABAYA, SURABAYA CITY
- FIRST : Converting the Accreditation Rating of Tourism Study Program in Undergraduate Program of Universitas Ciputra Surabaya, Surabaya City as stated in the Decree of the National Accreditation Agency for Higher Education Number 188/SK/BAN-PT/Ak-PPJ/S/I/2021 concerning University Accreditation Ranking of Universitas Ciputra Surabaya, Surabaya City to EXCELLENT with a Score of 327.
- SECOND : The Study Program Accreditation Rating as referred to in the FIRST Dictum is valid from December 30th 2025.
- THIRD : The Study Program Accreditation Rating as referred to in the FIRST Dictum may be revoked prior to the validity period ends, if the Tourism Study Program in Undergraduate Program of Universitas Ciputra Surabaya, Surabaya City is proven not to meet the Accreditation Rating requirements.



FOURTH : At the time when this Decree of the National Accreditation Agency for Higher Education takes effect, the Decree of the National Accreditation Agency for Higher Education Number 188/SK/BAN-PT/Ak-PPJ/S/I/2021 regarding the Tourism Study Program in Undergraduate Program of Universitas Ciputra Surabaya, Surabaya City, is revoked and no longer valid.

FIFTH : The Decree of National Accreditation Agency for Higher Education shall take effect on the date specified.
