THIRD: The college accreditation rating as referred to in the FIRST dictum may be revoked before its validity period expires, if Visual Communication Design (Makassar City Campus) at the Ciputra Surabaya University Undergraduate Program, Surabaya City, is proven not to meet the requirements of the accreditation rating;

FOURTH: The Study Program Accreditation Rating as referred to in the FIRST dictum is valid for two years starting August 22, 2023, and cannot be extended.
